Clint ISD Site Based Meeting Minutes – August 4, 2021

The Clint ISD Administration conducted a DSBDM Meeting on August 4, 2021 at 4:30 p.m. at the Clint ISD Administration Building.

- I. **Welcome** - Mr. James Littlejohn, Assistant Superintendent of Secondary Curriculum and Instruction, began the meeting at 4:30 p.m. welcomed the members, and thanked them for attending.
- II. **Recognition of Site Based Members with Expired Terms**
 - Mr. Littlejohn recognized all members who had completed their term at the end of the 2020-2021 school year. Certificates were handed out to all members in attendance. The members were also advised that they could vote on the agenda items at the meeting since elections would be held at the end of August for their replacements.
 - No action was taken on the item.
- III. **Approval of an Alternate Diagnostic Reading Assessment for 7th Grade**
 - Mr. Littlejohn reviewed the process Clint ISD must follow for all 7th grade students to assess them with an approved reading assessment instrument. Currently, the state adopted list has not be updated since 2018. TEA will allow a waiver for the assessment as long as all state criteria are used to assess the students. Clint ISD ELAR Coordinator, Yvonne Dominguez, reviewed the PowerUp assessment and the portions of the assessment that meet state guidelines.
 - A recommendation was made that we apply for a waiver to use the PowerUp assessment for the 2021-2022 school year.

IV. Texas COVID Learning Accelerated Support (TCLAS) Application

The Site Based Committee received an overview of the TCLAS grant application that Clint ISD staff was completing. The application has 10 decisions or parts that Clint ISD is considering. The administration has determined that we will apply for seven of the grant decisions. The grant may provide Clint ISD with more than \$4 million of resources and funding.

V. Teacher Incentive Allotment Update

The Site Based Committee was provided an update on the TIA process and the timeline for submitting Cohort C teachers for designations as well as the process and teacher groups for Cohort D. TEA has approved our application for Cohort D as well. By the end of the 2022-2023 school year, all teachers in Clint ISD will have the option of applying, completing and possibly earning the designations for additional compensation through the program.

VI. 2021-2022 District Improvement Plan

The Site Based Committee members were grouped with a Cabinet Representatives to review the goals, strategies, and funding of the District Improvement Plan (DIP). Each group reviewed a Goal of the DIP and made revisions and suggested updates to the DIP. Each sub-committee revisited the performance objectives, strategies and activities and a scribe recorded any revisions. The corresponding Cabinet member then updated the DIP online with the revisions. Each group was provided a copy of their goal to finalize. Data from the CNA was used to create all portions of the DIP. New grants, including the ESSER Grant, were added to the DIP as well.
