1. The REMS policy is presented to parents in the new school year during the Fall Open House which will occur in September 29, 2022. The policy can be found on our campus website and in our front office. The policy will also be sent to families as an emailed flyer, and an automated phone call will be made as to where to find the policy. All documents related to Parent and Family Engagement will be translated for our Spanish speaking parents to keep them informed.

2. Ricardo Estrada Middle School shall convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved; Section 1116 (c)(1)

An annual meeting will occur in the fall at Ricardo Estrada MS. It will be held at the Fall Open House on September 28, 2023. Parents will be notified via Blackboard and an automated call. The REMS Principal will conduct the meetings.

3. Ricardo Estrada Middle School shall offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, childcare, or home visits, as such services relate to parental involvement (in order to provide these activities, they must be addressed in the Campus Needs Assessment and the Campus Improvement Plan); Section 1116 (c)(2)

Ricardo Estrada Middle School is continuously seeking to offer meetings such as:

- Social Emotional Learning workshops for parents and students

4. strengthen those areas on campus to improve student academic performance. The process is ongoing throughout the school year.

5. Ricardo Estrada Middle School shall provide parents of participating children—
 - (A) send information about programs or activities under this part with enough time this way parents and family can plan to assist;
 - (B) a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards; and
 - (C) if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible;Section 1116 (c)(4)

Parents are informed about the Parent and Engagement Policy and activities pertaining to the campus via automated phone calls, Blackboard, social media, and on the campus website in both English and Spanish. The curriculum and assessment information are provided during the Fall and Spring Open House meetings. STAAR Academic Nights are also held to provide information on the state assessment and how to assist their child at home.

6. If the Campus Improvement Plan (CIP) under section 1114(b) is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the district staff responsible for the CIP. Section 1116 (c)(5)

The Campus Improvement Plan (CIP) is reviewed with the Campus Improvement Team (CIT) throughout the school year at least once during a nine-week period. Parents are openly and/or personally invited to participate for the opportunity to be given a voice and allowed to share their concerns and suggestions in creating and reviewing the CIP. All strengths and weaknesses are identified and addressed in the on-going process. The Campus Improvement Plan will also be explained to parents at the open house meeting on September 29, 2022 and at Spring Open House in February 2023.

7. To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, shall: Section 1116 (e)

Faculty and staff will be trained on the importance and value in building relationships with parents and families in the education of all students. The campus staff will work together in efforts on reaching out to parents, communicating and working with them to build communication on student academic success with programs such as 21st Century ACE (Afterschool Centers on Education) and PBIS (Positive Behavior and Interventions and Supports). Communities in Schools will also be a key factor in identifying and facilitating parent programs based on parent need as well as bridging the school and home environments.
